**DRIVING UNDER THE INFLUENCE (DUI) REINSTATEMENT REQUIREMENTS  
NEW LAWS EFFECTIVE JULY 1, 2010**

**ASSEMBLY BILL 91 (2009):** ESTABLISHES AN IGNITION INTERLOCK DEVICE (IID) PILOT PROGRAM. IF YOUR DRIVING UNDER THE INFLUENCE (DUI) CONVICTION OCCURRED IN ALAMEDA, LOS ANGELES, SACRAMENTO, OR TULARE COUNTY YOU WILL BE REQUIRED TO INSTALL AN IID IN ALL VEHICLES YOU OWN OR OPERATE UPON YOUR ELIGIBILITY FOR REINSTATEMENT OF THE DRIVING PRIVILEGE AND PROVIDE A DEPARTMENT OF MOTOR VEHICLES ORDERED VERIFICATION OF IGNITION INTERLOCK FORM (DL924). A \$45 ADMINISTRATIVE SERVICE FEE IS REQUIRED FOR THIS IID RESTRICTION. THE TERM OF THE DMV ORDERED IID RESTRICTION IS BASED UPON THE NUMBER OF PRIOR OFFENSES WITHIN 10 YEARS. IID INSTALLATION TERMS ARE AS FOLLOWS:

DRIVERS SUBJECT TO THE REQUIREMENTS OF ASSEMBLY BILL 91 MAY QUALIFY FOR AN IGNITION INTERLOCK DEVICE EXEMPTION. SEE THE ATTACHED EXEMPTION FOR IGNITION INTERLOCK DEVICE (IID) NOTICE (DL4055B) FOR MORE INFORMATION.

**SENATE BILL 598 (2009):** ALLOWS A SECOND OR THIRD OFFENDER CONVICTED OF DRIVING UNDER THE INFLUENCE OF **ALCOHOL ONLY** (\$23152 CVC ONLY) TO REINSTATE THE NON-COMMERCIAL DRIVING PRIVILEGE EARLY WHEN AN IID IS INSTALLED. COMMERCIAL DRIVERS ARE NOT ELIGIBLE FOR THIS IID RESTRICTION. A SECOND OFFENDER WHO APPLIES FOR EARLY REINSTATEMENT MUST SERVE AT LEAST 90 DAYS OF THE REQUIRED SUSPENSION PERIOD AND A THIRD OFFENDER MUST SERVE AT LEAST SIX MONTHS OF THE REQUIRED REVOCATION PERIOD BEFORE REINSTATING WITH AN IID. A DL924 AND \$45 ADMINISTRATIVE SERVICE FEE ARE REQUIRED FOR THIS IID RESTRICTION. ALL OTHER OFFENDERS SEE THE ATTACHED SUSPENSION OR REVOCATION ORDER FOR THE DATE OF EARLIEST REINSTATEMENT.

IN ADDITION TO THE ABOVE REQUIREMENTS FOR AB 91 AND SB 598, REINSTATEMENT IS SUBJECT TO THE FOLLOWING CONDITIONS:

- VIOLATION DATE MUST BE ON OR AFTER JULY 1, 2010.
- YOU HAVE CLEARED ALL OTHER OUTSTANDING SUSPENSION/REVOCATION ACTIONS ON YOUR DRIVER RECORD AND PAID ALL RELATED FEES INCLUDING ANY ADMINISTRATIVE IID FEES.
- YOU HAVE ENROLLED IN OR COMPLETED A DRIVING UNDER THE INFLUENCE PROGRAM AS REQUIRED IN CALIFORNIA VEHICLE CODE SECTION 13352. ENROLLMENT IN THE PROGRAM MUST BE AFTER THE DATE OF THE CURRENT VIOLATION. THE PROGRAM PROVIDER MUST SUBMIT THE NOTICE OF COMPLETION CERTIFICATE TO THE DEPARTMENT OF MOTOR VEHICLES BEFORE REINSTATEMENT IS GRANTED.
- YOU HAVE PROVIDED PROOF OF FINANCIAL RESPONSIBILITY (SR-22). SEE THE ATTACHED FINANCIAL RESPONSIBILITY FORM.

ADDITIONAL IID REQUIREMENT INFORMATION AND A TOLL FREE NUMBER FOR INSTALLATION ARE LOCATED ON THE BACK OF THIS FORM.

## ADDITIONAL IID INFORMATION

ONCE INSTALLED IN YOUR VEHICLE, THE IID MUST BE CALIBRATED AND INSPECTED BY A CERTIFIED INSTALLER AT INTERVALS NOT TO EXCEED 60 DAYS. THE INSPECTIONS ENSURE THE DEVICE IS WORKING PROPERLY WITH NO EVIDENCE OF TAMPERING

ONCE PROOF OF INSTALLATION OF AN IID (DL 924) HAS BEEN PROVIDED, IF AT ANY TIME DURING THE RESTRICTION PERIOD, THE DEPARTMENT RECEIVES NOTIFICATION FROM THE INSTALLER THAT A PERSON FAILS TO COMPLY WITH ANY OF THE IID REQUIREMENTS, THE FOLLOWING WILL APPLY:

- **ASSEMBLY BILL 91 (2009)**: DMV WILL PAUSE THE IID RESTRICTION. FOLLOWING A NOTICE OF NON-COMPLIANCE, AN INDIVIDUAL MUST PROVIDE A NEW DL 924 FORM. UPON RECEIPT OF THE NEW DL 924, DMV WILL THEN IMPOSE THE REMAINDER OF YOUR IID RESTRICTION PERIOD.
- **SENATE BILL 598 (2009)**: DMV SHALL IMMEDIATELY TERMINATE THE RESTRICTION AND IMMEDIATELY SUSPEND OR REVOKE THE PRIVILEGE TO OPERATE A MOTOR VEHICLE. THE PRIVILEGE SHALL REMAIN SUSPENDED OR REVOKED FOR THE REMAINING PERIOD OF THE ORIGINATING SUSPENSION OR REVOCATION AND UNTIL ALL REINSTATEMENT REQUIREMENTS ARE MET.

ANY OFFENDER WHO IS REQUIRED TO OPERATE A MOTOR VEHICLE OWNED BY HIS/HER EMPLOYER DURING THE COURSE OF HIS/HER EMPLOYMENT, MAY OPERATE THE VEHICLE WITHOUT INSTALLATION OF AN APPROVED IID IF THE EMPLOYER HAS BEEN NOTIFIED THE EMPLOYEE'S DRIVING PRIVILEGE HAS BEEN RESTRICTED PURSUANT TO SECTION 23700 CVC. THE EMPLOYEE MUST HAVE PROOF OF THAT NOTIFICATION IN HIS/HER POSSESSION OR IN THE VEHICLE. DMV WILL PROVIDE ANY REQUESTING PARTICIPANT WITH A NOTICE TO EMPLOYERS, IGNITION INTERLOCK RESTRICTION (DL 923) FORM.

INDIVIDUALS SUBJECT TO AN IID RESTRICTION SHALL NOT OPERATE A MOTORCYCLE FOR THE DURATION OF THE IID RESTRICTION TERM.

**EXEMPTION FOR IGNITION INTERLOCK DEVICE (IID)**

I AM EXEMPT FROM THE INSTALLATION OF AN IGNITION INTERLOCK DEVICE (IID) PURSUANT TO CALIFORNIA VEHICLE CODE (CVC) §23700 BECAUSE I MEET ALL OF THE FOLLOWING CIRCUMSTANCES:

- I DO NOT OWN A VEHICLE.  
**NOTE: IF YOU OWN A VEHICLE(S) THAT DOES NOT RUN OR FOR WHICH YOU HAVE AN APPROVED PLANNED NON-OPERATION (PNO) YOU DO NOT QUALIFY FOR AN EXEMPTION.**
- I DO NOT HAVE ACCESS TO A VEHICLE AT MY PLACE OF RESIDENCE.
- I NO LONGER HAVE ACCESS TO THE VEHICLE USED WHEN I WAS ARRESTED FOR THE VIOLATION THAT RESULTED IN THE ABOVE CONVICTION.

I ACKNOWLEDGE THAT I AM:

- ONLY ALLOWED TO DRIVE A VEHICLE THAT IS FITTED WITH AN OPERATING IID.
- REQUIRED TO HAVE A VALID DRIVER LICENSE BEFORE I CAN DRIVE.
- SUBJECT TO THE REQUIREMENTS OF THIS SECTION WHEN I PURCHASE OR HAVE ACCESS TO A VEHICLE.
- REQUIRED TO OPERATE A MOTOR VEHICLE DURING THE COURSE OF MY EMPLOYMENT THAT IS OWNED BY MY EMPLOYER. I HAVE NOTIFIED MY EMPLOYER THAT MY DRIVING PRIVILEGE HAS BEEN RESTRICTED PURSUANT TO VC 23700 AND WILL CARRY PROOF OF THAT NOTIFICATION IN MY POSSESSION WHEN OPERATING THE EMPLOYER'S VEHICLE WITHOUT AN IID.

IF YOU ARE ELIGIBLE AND WISH TO FILE AN EXEMPTION, COMPLETE AND MAIL THIS FORM TO THE ABOVE ADDRESS. THE POSTMARK DATE MUST BE NO LATER THAN 30 DAYS FROM THE MAILING DATE OF THE ATTACHED SUSPENSION OR REVOCATION NOTICE.

THE DEPARTMENT WILL VERIFY THE ACCURACY OF THE ABOVE INFORMATION BEFORE APPROVING AN IID INSTALLATION EXEMPTION. THE EXEMPTION WILL NOT BE GRANTED IF THIS INFORMATION IS INCORRECT OR IF IT IS DETERMINED AT THE TIME YOU BECOME ELIGIBLE TO REINSTATE YOUR DRIVING PRIVILEGE THAT YOU DO NOT MEET ALL THE ABOVE EXEMPTION REQUIREMENTS.

**NOTE: THE APPLICATION FOR EXEMPTION WILL NOT BE PROCESSED IF THE INFORMATION PROVIDED BELOW IS ILLEGIBLE OR INCOMPLETE.**
