# IMPORTANT - READ CAREFULLY

## WARNING:

If you fail to appear in court as you have promised, you may be arrested and punished by 6 MONTHS IN JAIL AND/OR A \$1000 FINE, regardless of the disposition of the original charge (veh. Code sec. 40508, or Pen. Code sec. 853.7). In addition, the Department of Motor Vehicles will WITHHOLD the issuance or renewal of your driver's license, and may revoke or suspend your driving privilege for vehicle code offenses.

## BAIL INFORMATION

The clerk of the court in which you have promised to appear can accept a deposit of bail to guarantee your appearance. For some offenses the court may accept this deposit by mail, and permit it to be forfeited, thereby relieving you of your duty to appear. Under Vehicle Code section 13103 a bail forfeiture is a conviction of the charged offenses. Bail information is not available from the citing agency. A courtesy notice may be mailed to the address shown on this citation indicating whether an appearance is mandatory or indicating the required deposit of money which may be forfeited. If you do not receive that notice within two weeks from the date you were issued this citation, appear in court on or before the time and date specified on the face of the citation. Make check or money orders payable to the Clerk of the Court.

## JUVENILES:

When you appear in court, bring your driver's license. You must be accompanied by your parent(s) or guardian(s).

## CORRECTABLE VIOLATIONS:

Those driver's license, vehicle registration, and mechanical violations cited in accordance with Vehicle Code section 40610a will be dismissed by the court if PROOF OF CORRECTION is presented to the court by mail or in person, on or before the appearance date. Violation of the Vehicle Code section 16028 (automobile insurance) may be dismissed by the court upon your showing that evidence of financial responsibility, in a form consistent with Vehicle Code section 16028.4, was valid at the time this citation was issued.

Proof of correction should be obtained for driver's license, registration, and equipment violations. CORRECTION EQUIPMENT VIOLATIONS IMMEDIATELY.

## METHODS FOR OBTAINING CERTIFICATION OF CORRECTION:

1. Pollution control device violations must be certified by a smog check station licensed by the California Bureau of Automobile Repair.
2. Lamp, brake, and exhaust system violations may be certified as corrected by an authorized inspection and installation station for the specific violation(s).
3. Registration and driver's license violations may be certified as corrected at an office of the Department of Motor Vehicles or by any clerk or deputy clerk of a court.
4. Proof of correction, except for violations which must be cleared at a certified installation and inspection station, may be obtained during normal business hours at Calistoga Police Department, 1235 Washington Street, Calistoga, CA.
